### **Why it's important: Statistics**

### **Definitions and terms: Some things to consider**

Let's start with understanding some foundational concepts such as gender identity, gender expression, sex assigned at birth and sexual orientation. Select and explore all of the terms on the genderbread figure to learn more!

### **Definitions and terms: SOGI terms and definitions**

It is important to remember that gender identity and sexual orientation are independent of one another. Sexual orientation refers to how a person defines their physical and emotional attraction to others. Whereas gender identity is a person's internal sense of their gender. And some individuals don't identify with any gender at all.

Gender identity is very personal. Not everyone will use a label for their gender identity or their sexual orientation and that's okay. Language depends on the person, different terms can mean different things depending on the person. On the following pages, you can explore terms and definitions associated with sexual orientation and terms associated with gender identity.

### **Definitions and terms: Sexual orientation vocabulary**

These are terms associated with sexual orientation. Keep in mind that sexual orientation is how a person defines their physical and emotional attraction to others. Select the terms to find out more details about sexual orientation.

### **Definitions and terms: Gender identity vocabulary**

These are terms associated with gender identity. Gender identity is a person's internal sense of their gender. Select the terms to find out more details about gender identity.

### **Dimensions system updates: Technology enhancing care!**

The plan to use tablets to enable all patients to input their demographics allows for comfort and privacy. Confidentiality is key! Team members must be aware of the potential impact on a patient if sexual orientation and gender identity is inappropriately shared with a patient's friend or family member.

## **Service Standards in action: The SOGI perspective**

Novant Health strives to deliver a remarkable healthcare experience for each of our patients, and knowing how our patients identify in terms of their sexual orientation and gender identity helps us to achieve that goal. Essential to this is the consistent application of our Service Standards - know me, respect me, care about me and delight me. In this section, two videos are featured – one shows a lack of service standards and the second illustrates our service standards in action. As you review the following videos make observations on how we do or do not fulfill our service standards and the effect on our patient, Roberta who is a transgender woman.

## **Service Standards in action: Debrief of the negative example**

The video you just viewed was a demonstration of what it looks like if our service standards, are *not* used and how those interactions run counter to our mission vision and values. ## **Make it remarkable!**

Work through the checklist of items on the clipboard by selecting them to explore remarkable behaviors we can demonstrate throughout every patient touchpoint and all encounters when caring for our LGBTQ patients.

### **Make it remarkable: Communication strategies**

Here are some strategies for effectively communicating with our LGBTQ patients. Additional narration is available for some of the listed items where indicated by the sound icon. Click the sound icons to hear that narration. For your first pass through this page, you must listen to those additional narration items prior to advancing to the next page.

- **(bullet 3)** For example if your patient says, my wife, or my husband, or uses the words my spouse or my partner, mirror this language.
- **(bullet 4)** Think about the language we use every day and find ways to replace words or phrases that assume a certain gender identity or sexual orientation. For example, avoid using words like sir, ma'am, Mrs., or Mr. You can make some very simple adjustments in language and have a remarkable impact. For example, instead of saying, "How may I help you, sir?" you can simply say "How may I help you?" and instead of *the phrase*, "She is here for her appointment." You can easily say, "The patient is here in the waiting room." And "What are your mother and fathers' names?" can be replaced with "What are your parents or guardians' names?"
- **(bullet 5)** If you do make a mistake then confidently and quickly apologize and move forward. For example, if you greet a patient with their legal name and that is not what they go by, say, "I'm sorry." State their preferred name and say. "I will use this name going forward."

### **Make it remarkable: Some closing thoughts**

Here are some closing thoughts to consider. It is okay to still have questions. By exploring this learning and continuing to learn more our confidence will grow which will translate to patients comfort. The remarkable behaviors that you explored earlier in this section help us deliver on the remarkable patient experience. Take a moment to consider what you can start doing today.
